Black Star Equestrian offers a full training and lesson packages to better serve your needs. Full Training includes feeding of Client provided supplements mixed with custom CAVALOR feed program based on your equine's needs. Blanketing during winter months. We also offer individual lessons and schooling sessions for customers not in training, see below for pricing.

Full Training:

\$725 per month with client horse

\$875 per month with client horse including full grooming

Services include but not limited to: Pessoa Lunging Session, Turn-Out, Trainer Rides and Client Lessons.

Part Training:

\$600 per month includes Three professional services per week with Clients Horse.

TheraPlate:

\$40 per month for all horses in Full training

LESSONS:

Lessons are offered for children and adults at all levels. Many of our lessons are given in small groups because we have found that riders learn faster when they are in a group where they can watch and learn from their peers. We have lesson instructors specializing in different levels of riding. BSE has a limited number of lesson horses and ponies that are available for the more beginner riders interested in riding at a lower level and showing in local schooling shows. Tack is provided for the lesson horses, but it is recommended that you have your own saddle if you decide to commit to a more serious lesson program or lease options.

Black Star Equestrian requires a 24 hour cancellation notice for all lessons in order for a make up date to be issued. All lessons cancelled less than 24 hours will be charged full price.

Black Star Equestrian has a select number of small and medium ASTM Certified helmets for use during your lesson. Please check availability on sizing. Black Star Equestrian lesson students should invest in their safety. Helmet, half chaps, paddock boots and gloves should be purchased within a reasonable amount of time. Kristy will assist you in choosing the right purchase for you. Riders coming for lessons must be dressed appropriately for safety reasons.

HORSE SHOW CHARGES.

Effective 01.01.2017

HORSE SHOW CHARGES:

Checks for entries, hauling and braiding are required in advance for each horse show.

Trainer Expenses

A flat rate that includes meals, laundry and local transportation. This fee starts the day your horse arrives at the horse show and continues until the last day your horse is at the show.

Horse Expenses

Will be divided by number of horses attending show. This fee includes hotels, transportation (airfare, if applicable) and per-diem. Services include grooming, feeding, packing & unpacking, tack room set-up & tear down, buckets, stall cleaning, aisle maintenance, ringside attendance and use of horse show equipment. It includes security, laundry and purchase of necessary supplies. (If additional grooms are needed, the cost will be divided by the number of horses). When possible, feed, bedding, tack and grooming stalls will be divided and billed through the horse show office.

Prize Money

15% of prize money won by horses ridden by Kristy Miller in classes offering \$1,500 or more.

Medications

Individually charged by horse.

Horse Show Deposits

A Horse Show deposit is necessary at least one (1) week prior to the event.

SALES, PURCHASES AND LEASES

SALES, PURCHASES AND LEASES

COMMISSION: 15% of sale, purchase, or lease price (full term)- Non Training Clients. 10% of sale, purchase or lease price (full term)- Training Clients.

EXPENSE REIMBURSEMENT: Client is responsible for reimbursing Black Star Equestrian for all expenses incurred, whether or not a transaction is consummated. These expenses may include, but are not limited to; postage, FedEx, telephone calls, videotapes/DVD's, all advertising, fuel (IRS 2017 rate of \$.53.5 cents per mile), hauling, vet fees, daily stall fees, training fees, etc.

TRAVEL COSTS: Client is responsible for payments of all travel costs; including transportation, lodging, food, etc, whether or not a transaction is consummated. Trainer will charge a \$100 a day per diem when traveling to look for horses for the client (plus IRS 2017 rate of \$.53.5 cents per mile). A 50% refund will be given and applied to the trainer's commission when a horse is purchased or sold. This per diem does not apply when horses are local or are being tried at a horse show.

Payment is due at consummation of transaction with late charge of 5% accruing after 15 days from that date.
